Legacy Affiliate Membership Category Guidelines applicable to Legacy Affiliate Members (a/k/a Affiliate Exchangers)

LEGACY AFFILIATE MEMBERSHIP CATEGORY

These Membership Category Guidelines constitute Exhibit C to the Disclosure Guide to the Capital Vacations Global Exchange Network (“Disclosure Guide”) and is intended to provide you with additional information concerning your membership in the Exchange Network as a Member in the “LEGACY AFFILIATE” MEMBERSHIP CATEGORY. Capitalized terms used but not otherwise defined herein have the meanings ascribed to them in the Capital Vacations Global Exchange Disclosure Guide. The Effective Date of these Membership Category Guidelines is January 23, 2025.

A. MEMBERSHIP CATEGORY GUIDELINES

The purpose of these Membership Category Guidelines is to provide you with specific information concerning certain of the Exchange Network Benefits available to you as a Member within the Exchange Network’s Legacy Affiliate Membership Category (the “Legacy Affiliate Membership Category”). This Membership Category Guidelines applies to you and the other Members in the Legacy Affiliate Membership Category, referred to herein as “Legacy Affiliate Members.” All references herein to the term “Disclosure Guide” shall mean and include the Capital Vacations Global Exchange Disclosure Guide, together with and including these Membership Category Guidelines attached thereto as Exhibit A. The terms of these Membership Category Guidelines are hereby incorporated into the Capital Vacations Global Exchange Disclosure Guide.

B. LEGACY AFFILIATE MEMBERSHIP CATEGORY

Your participation in the Exchange Network shall be as a Legacy Affiliate Member. Legacy Affiliate Members are Affiliate Members and are not Direct Members. Your right to continue Membership as a Legacy Affiliate Member is conditioned upon your continued ownership of your Vacation Interest at an Affiliate Resort, as well as the conditions for Membership set forth in Exhibit B, Section D of the Disclosure Guide and the other Exchange Network Documents. Should any of those conditions cease to be met, your Membership may be terminated by Exchange Company.

Your Membership in the Exchange Network is further dependent upon the continued affiliation of your Resort or Resort Plan with the Exchange Network. Should the Affiliate

relating to your Home Resort or Resort Plan (“your Affiliate”) fail to perform its obligations to Exchange Company under its Affiliation Agreement or should such Affiliation Agreement expire without renewal or terminate, your Membership in the Legacy Affiliate Membership Category may be terminated or, in Exchange Company’s sole discretion (which may include payment of a conversion fee), your Membership may be converted to a Direct Membership within another Membership Category as determined by Exchange Company and thereafter be subject to the Membership Category Guidelines applicable to such Direct Membership Category.

In addition, your consent to the Disclosure Guide constitutes your consent to the terms and conditions of the Affiliation Agreement between Exchange Company and your Affiliate and you are subject to all acknowledgements, consents, understandings and agreements of your Affiliate thereunder.

C. AVAILABLE RESORTS AND ACCOMMODATIONS

Available Resorts and Accommodations. The name and address of each Available Resort available to the Legacy Affiliate Membership Category as of the Effective Date, including the number of Accommodations available for occupancy at each such Affiliate Resort, expressed in the numerical groupings (for the number of Accommodations therein) of 1-5; 6-10; 11-20; 21-50; and 51 and over, is set forth in the Disclosure Guide. Additions, modifications and deletions of Affiliate Resorts and the Accommodations therein are at sole discretion of Exchange Company. In making additions of Affiliate Resorts, Exchange Company may consider factors such as size, location, and quality of the Resort and its Accommodations. For a full set of Available Resorts see Exhibit B, SCHEDULE 1 of the Disclosure Guide.

THE RESORTS AVAILABLE TO LEGACY AFFILIATE MEMBERS MAY CHANGE FROM TIME TO TIME AS DETERMINED BY EXCHANGE COMPANY.

Non-Affiliate Exchange Network Inventory. In addition to the Affiliate Resorts set forth above, additional Resorts, Holiday Property and Accommodations may be available for Exchanges, Bonus Time and/or Additional Benefits from time to time as Non-Affiliate Exchange Network Inventory which has been deposited into the Exchange Network Deposit Pool by Direct Members (i.e., a Members whose Home Resort is not an Affiliate Resort) or otherwise made available by Exchange Company to Members through the Exchange Network. Such Non-Affiliate Exchange Network Inventory will be listed on the Exchange Network Website from time to time; however, it is not possible or relevant for Exchange Company to list (1) the name and address of each Resort or Resort Plan relating to such

Non-Affiliate Exchange Network Inventory; (2) the number of Accommodations within each such Resort or Resort Plan that are available for occupancy and which qualify for participation in the Exchange Network; or (3) the number of Exchange Network Members for each such Resort or Resort Plan. Exchange Company shall have the sole right to determine which Non-Affiliate Exchange Network Inventory may be available to various Membership Types and to Members, generally.

Non-Affiliate Exchange Network Inventory varies at any given time because availability is not based on the “participation” of any particular Resort or Resort Plan in Exchange Network; rather, availability of Non-Affiliate Exchange Network Inventory is dependent upon factors outside of Exchange Company’s control, such as which Direct Members deposit their Vacation Interests into the Exchange Network Deposit Pool from time to time, as well as which additional Non-Affiliate Exchange Network Inventory the Exchange Company may be able to add to the Exchange Network Deposit Pool from time to time. The constantly changing Resorts in which Non-Affiliate Exchange Network Inventory may be available to Exchange Network Members through the Exchange Network varies in size from a few Accommodations to several hundred per Resort. Each Exchange Network Member is given a detailed description of the applicable Resort before receiving a Confirmed Reservation for Non-Affiliate Exchange Network Inventory at any such Resort.

D. RESERVATIONS BY LEGACY AFFILIATE MEMBERS

Legacy Affiliate Member may make Exchange Requests up to two (2) years in advance and no less than two (2) days in advance of the desired travel dates.

Other Reservation Requests, including Bonus Time and for Additional Benefits, may be made as provided on the Website or otherwise permitted by Exchange Company from time to time.

Timing of Reservations is subject to change as determined by Exchange Company in its sole discretion.

E. ADDITIONAL BENEFITS

Exchange Company may from time to time offer Exchange Network Inventory and various other benefits to Legacy Affiliate Members as Additional Benefits. Additional Benefits which remain available to Legacy Affiliate Members are set forth on the Legacy Affiliate Member Webpage. Exchange Company has the right to amend, replace, add and/or delete Additional Benefits available to Legacy Affiliate Members in its sole and absolute discretion.

F. AMENDMENTS

Exchange Company reserves the right to amend the Disclosure Guide, including these Membership Category Guidelines, at any time and for any lawful reason in its sole discretion. Such amendments may include, without limitation, amendments to the fees, benefits and reservation procedures and priorities described herein and therein. Any such amendments will be effective as to each Member when they are posted on our Website and we have delivered notification thereof to you and/or you have used the Website, upon the renewal of your Membership, or upon your receipt of a Confirmed Reservation or your receipt of any Exchange Network Benefits, whichever occurs first, and shall continue to be effective, as amended from time to time, until Membership is terminated or ended or an amended version of these Membership Category Guidelines becomes effective, from which point the amended document shall control.

Members will be provided with notice of all material changes to these Membership Category Guidelines subsequent to the Effective Date of these Membership Category Guidelines. Exchange Company reserves the right to provide such notice via email and/or posting on the Exchange Network Website. Exchange Company further reserves, in its sole discretion, the right to modify, waive or eliminate any term or condition with respect to any Member, including, without limitation, any and all fees. Should Exchange Company allow any Member to deviate from the provisions hereof, Exchange Company may insist on strict compliance at any time after written notice. Exchange Company's silence or inaction may not be used to establish a waiver, consent, course of dealing, implied modification or estoppel. All modifications, waivers, approvals and consents of or under these Membership Category Guidelines by Exchange Company must be in writing and signed or promulgated by Exchange Company's authorized representative to be effective.
